AGREEMENT FOR EASEMENT EXTINGUISHMENT

THIS AGREEMENT, made this ____ day of _____, 2015, by and between KING COUNTY WATER DISTRICT NO. 90, a municipal corporation of King County. Washington, hereinafter termed the "District" and QUADRANT HOMES, hereinafter termed the "Grantors/Owners",

WHEREAS, Grantors are the owners of land in Renton, Washington, legally described as follows:

Tract "X" of King County Short Plat No. 880059, recorded under Auditor's file No. 8107010684, records of King County, Washington.

WHEREAS, the District owns an easement for water lines across the Grantors/Owners property and the Grantors/Owners desire that the District extinguish and terminate the easement:

WHEREAS, the District is willing to extinguish the easement upon the condition that the

water main in the easement shall not be physically removed, that is the water main shall be abandoned in place, and the Grantors/Owners agree for themselves, their heirs, successors, and assigns to hold harmless and indemnify the District its agents, employees, insurers, and all other persons, firms or corporations that may be liable, of and from any and all past, present, or future claims, demands, obligations, actions, causes of action, rights, damages, costs, losses of service, expenses and compensation or punitive damage which may presently exist or which may hereafter accrue or otherwise be acquired on account of, or in any way growing out of, the District's installation operation maintenance and abandonment of the easement and/or water main.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND THE MUTUAL COVENANTS, PROMISES AND AGREEMENTS HEREIN CONTAINED, THE PARTIES AGREE AS FOLLOWS:

- 1. The District hereby extinguishes the easement for water line(s) across Grantor's/Owner's real property as contained in that instrument recorded in King County Records under Recording Number 811124049.
- 2. The Grantors/Owners for themselves and their heirs, successors, and assigns acknowledge and agree that the water main in the easement shall not be physically removed and shall be abandoned in place and the Grantors/Owners for themselves, their heirs, successors, and assigns further agree to hold harmless and indemnify the District, its agents, employees, insurers and all other persons, firms or corporations that may be liable of and from any and all past, present or future claims, demands, obligations, actions, causes of action, rights, damages, costs, losses of service, expenses and compensation or punitive damages, which may now exist or which may hereafter accrue or otherwise be acquired on account of, or in any way growing out of the District's installation, maintenance, operation, or abandonment of the easement or the water main. The Grantors/Owners acknowledge and agree that this indemnification and hold harmless shall be fully binding on themselves, their heirs, successors, and assigns.
