**A RESOLUTION** of the Board of Commissioners of King County Water District No. 90, King County, Washington, accepting completed contract from B&B Utilities and Excavating, LLC, pertaining to the SR900 Green Creek Box Culvert Water Main Relocation Project; Contract 2017-1.

**WHEREAS**, the District heretofore granted Contract 2017-1 to B&B Utilities and Excavating, LLC, for the SR900 Green Creek Box Culvert Water Main Relocation Project; and

**WHEREAS**, the District's project engineer, Stantec Consulting Services, Inc., has apprised the Board of Commissioners that the contract has been completed to the District's specifications and final amounts determined; and

**WHEREAS**, the final total contract price approved and incurred for Contract 2017-1 has now been determined to be \$78,039.96, not including sales tax; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of King County Water District No. 90, King County, Washington, as follows:

**SECTION 1:** That Contract 2017-1 between B&B Utilities and Excavating, LLC Construction and King County Water District No. 90 for the Green Creek Box Culvert Water Main Relocation Project, is hereby granted final approval.





Dear Jeff,

Construction Change Order No. 1 involves labor, materials, and equipment charges for excavation of the SR900 roadway to temporarily cap the existing 12-inch DI water main, then backfill and steel plate the roadway. The water main isolation area was determined to be too short of a distance for safe excavation based on the WSDOT contractor's construction method for installation of the proposed culvert and the soils on site. This required the excavation to be done a second time. A price adjustment of Bid Item # 4 for 12-inch DI pipe in excess of 100 LF is also included in this change order. No change in Contract time is included in this Change Order.

The following changes to the Contract are hereby authorized:
