RESOLUTION NO. 1038

A RESOLUTION of the Board of Commissioners of King County Water District No. 90, King County, Washington, authorizing award of contract for purchase of new International 4400 truck with Dump Body through the Washington State Purchase Contract, purchase order 01513, through North End Trucks, with Asphalt Rear Gate Chutes, backup camera, dump body vibrator, and tarping system;

WHEREAS, the District's Dump Truck is not currently operational and has reached the end of its service life for the functions required of it by the District; and

WHEREAS, the old Dump Truck should be replaced with a new one able to perform at the levels and reliability required for the District's functions; and

WHEREAS, time is of the essence to obtain a truck with dump so that the day to day work of the District may proceed without further delay; and

WHEREAS, the market conditions are such that obtaining a truck with dump will normally take several weeks which would cause extreme and unreasonable difficulty to the District's operations, and that a truck with dump has been located and is available for timely delivery through the established State Vendor Roster; and

WHEREAS, the State of Washington has established a Vendor Roster in accordance with Washington State bid laws; and

WHEREAS, the District has determined that an International 4400 truck with Dump Body and appurtenances would meet the current requirements of the District, and is the lowest price of proposals procured by the District; and is from a Washington State supplier; and

WHEREAS, in accordance with RCW 57.08.050(4), the District has confirmed that the vendors, and the price and terms for the purchases are reasonable and proper.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of King County Water District No. 90, as follows:

SECTION 1: That a contract for the purchase from North End Trucks through the Washington State Vendor Roster is hereby authorized in the amount of \$112,175.00, not including sales tax; the specifications for the truck, dump body and appurtenances shall be in accordance with the provisions and conditions on file at the District.

SECTION 2: That the process for the purchase shall be in accordance with the vendor roster provisions of RCW 57.08.050(4); and with District Resolutions.

SECTION 3: That the District Manager is authorized to execute the Contract, and a copy of each shall be maintained for examination and inspection at the District's office.
