# ADDENDUM TO APPLICATION AND AGREEMENT TO ALLOW CONSTRUCTION OF EXTENSION TO FACILITIES

#### TO: KING COUNTY WATER DISTRICT NO. 90

The undersigned, Michael and Cynthia Merritt, husband and wife ("the Developer"), previously made application to King County Water District No. 90, King County, Washington ("the District"), for permission to construct and install an extension to the District's water facilities in the public right-of-way under the District's franchise, and/or upon easements approved by the District, and to connect to the District's water distribution system as set forth in the Application and Agreement to Allow Construction of Extension to Facilities ("the Extension Agreement") dated October 7, 2016, for the Merritt Short Plat water main extension Project, located at 2505 Lyons Ave NE, Renton, WA 98059, King County Parcel #032305-9108.

At the time of application, Michael and Cynthia Merritt listed the developer as CME6 LLC on the Extension Agreement.
