RESOLUTION NO. 1062

A RESOLUTION of the Board of Commissioners of King County Water District No. 90, King County, Washington, adopting the 2019-2028 Regional Water Use Efficiency Goal in cooperation with the Saving Water Partnership (SWP)

WHEREAS, The State of Washington has adopted Water Use Efficiency (WUE) Rule as an outgrowth of the State's Municipal Water Law, providing that water suppliers use water more efficiently in exchange for water right certainty and flexibility to meet future demand, as generally set forth in WAC 246-290, and goal requirements set forth in WAC 246-290-830 and WAC 246-290-840;

WHEREAS, The District is a member of the SWP;

WHEREAS, the SWP proposed a new water use efficiency goal to: "Keep the total average annual retail water use of Saving Water Partnership members under 110 mgd through 2028, despite forecasted population growth, by reducing per capita water use."

WHEREAS, The District gave notice to the public of the right to comment on the 2019-2028 proposed water use efficiency goal, which was scheduled for July 2, 2019, at the regularly scheduled Board of Commissioners meeting;

WHEREAS, The notice of the public meeting was made more than two week prior to the July 2, 2019, meeting, which notice included the purpose of the meeting, date, time, location, and information about where supporting materials for the goal could be reviewed;

WHEREAS, At the regularly scheduled Board of Commissioners meeting on July 2, 2019, the District invited public comment on the proposed WUE goals and no comments were received or otherwise made;

WHEREAS, The District staff recommended to the Board that it adopt the 2019-2028 water used efficiency goals in cooperation with the SWP.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of King County Water District No. 90, King County, Washington, as follows:


SECTION 1: King County Water District No. 90 adopts the following ten-year regional water use efficiency goal: Keep the total average annual retail water use of Saving Water Partnership members under 110 mgd through 2028, despite forecasted population growth, by reducing per capita water use.

EFFECTIVE DATE, SEVERABILITY, AND REPEALER

a. **Effective Date.** This Resolution shall be effective upon adoption by the Board of Commissioners.

b. **Severability.** If any Section, sentence, clause or part of the Resolution is for any reason determined invalid, such determination shall not affect the remaining portions of the Resolution.
