RESOLUTION NO. 1070

A RESOLUTION of the Board of Commissioners of King County Water District No. 90, King County, Washington, providing for a special charge to customers residing in unincorporated King County resulting from King County instituting a rental charge

for infrastructure located in County right-of-way.

WHEREAS, On November 7, 2016, King County (the County) passed Ordinance 18403

requiring utilities, including the District, to pay for their ability to use the County's right-of-way for

placement of utility infrastructure; the County refers to this payment as "franchise compensation"

and is akin to annual rent charged for the use of the right-of-way. Such charge is levied against

only those portions of utility infrastructure within unincorporated King County; and

WHEREAS, The District, in partnership with several other water-sewer districts, entered into

litigation against the County seeking to have the court declare that the "franchise compensation"

was not authorized or otherwise valid under the law; and

WHEREAS, The districts successfully challenged the "franchise compensation" to the King

County Superior Court with a finding that the charge was not authorized by law; however, the

Washington State Supreme Court reversed that decision and found that the County could impose

the "franchise compensation" against the districts; and

WHEREAS, King County sent the District an "Estimation of Franchise Compensation" on

March 23, 2018, calculating the "franchise compensation" amount due to King County on an annual

basis of \$175,246.00; the District disputes the calculation and will engage further with King County

in determining the appropriate charge amount, if any; and

WHEREAS, The District Commissioners have the powers "to fix rates and charges for

water" service pursuant to RCW 57.08.005 and to "provide for revenues by fixing rates and

charges" including classifying customers pursuant to RCW 57.08.081; and

WHEREAS, The District has determined that the "franchise compensation" is chargeable to

only that class of customer within unincorporated King County; and

WHEREAS, The District has calculated the amount due under the County calculation from

the date the "franchise compensation" was instituted to present is approximately \$40.00 per

customer within unincorporated King County, with an ongoing rate of \$3.00 per month;

WHEREAS, The District will negotiate further with King County and appropriate adjustments

to the rate, including additional charges or credits, will be passed on to customers within

unincorporated King County;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of King County

Water District No. 90, King County, Washington, as follows:

SECTION 1: District staff is directed to not collect "franchise compensation" charges

incurred prior to January 7, 2020, from customers within unincorporated King County, in the amount

of \$40.00, pending further negotiations with King County of further decision of the Commissioners.

SECTION 2: District staff is directed to collect monthly franchise compensation charges

from each customer within unincorporated King County beginning with the first billing after January

7, 2020, in the amount of \$3.00 per month, billed bi-monthly. Such funds will be held by the District

pending final negotiation with King County, or further decision of the Commissioners.

SECTION 3: District staff is directed to notify customers within unincorporated King County

of the "franchise compensation" charge, including the history, litigation, amount and status of such

charge, and to provide customers with information that may be helpful to them giving input to King

County regarding the adoption and institution of the charge.
