# THE CITY OF RENTON IMPOSES A UTILITY TAX BEGINNING JANUARY 2021

Beginning in January of 2021, the City of Renton has elected to charge a 6.8% Utility Tax on King County Water District No. 90's Customers that live within the City boundaries.

According to the City of Renton, "The tax revenues collected from the sales of utilities are part of our general fund. The general fund is used to meet the basic services the City provides including, but not limited to police protection, parks and recreation, human services, municipal court, street maintenance and planning, economic development, and administrative functions. All residents within Renton City limits benefit from these services."

On your water bill, you will see a line item at the bottom of your charges with "COR Tax." This 6.8% tax will be added to the total water bill, excluding street light charges and fire service. Because street lights and fire service are deducted from the total tax, your actual tax rate will be slightly less than the full 6.8%. \*Actual numbers are still being calculated. The effective tax rate will be noted on your bill. For details on this tax, please see City of Renton's Ordinance 5944.

Customers who do not live within the City of Renton boundaries are currently being charged the King County Right of Way Rental Fee of \$3.00 per household per month. The final rate for this fee is still being negotiated and/or litigated. The amount of this fee is expected to change once negotiations with King County are concluded.

Depending on where you live, all District Customers will either have the King County Right of Way Fee or the City or Renton Utility Tax on their bills.

#### CARES ACT / CORONAVIRUS RELIEF FOR UTILITY BILLS

#### 2021 Rate Increase

Rates will increase starting with the January 2021 bills. Residential base rates will increase by \$2.75 to \$62.50 and the usage tiers will increase to \$3.75 (6-15 Ccf's), \$4.25 (16-25 Ccf's) & \$5.00 (26+ Ccf's). For a customer using 10 Ccf's, the total bill will be \$81.25 for a two-month period. The summer surcharge for usage will be \$1.00 per Ccf. The summer surcharge applies to bills between June and September. A Ccf is 100 cubic feet of water or 748 gallons. In other words, you pay just \$0.01 per gallon of water or about \$1.35 per day per household.

The District has a low-income assistance program for those over 55 or permanently disabled. The low-income base rate for 2021 is \$26.25. You may qualify if your income is below \$35,000 for a single person and \$45,000 for a family.

## **Annual Report on Senior Citizen & Permanently Disabled Discount Rate**

Last year, KCWD90 had 55 customers participate in our "Low Income Rate for Senior Citizens or Permanently Disabled" Discount Rate Program. The total cost to the District for the ninth year of this program (July 1, 2019, through June 30, 2020) was \$11,056.

In 2020, customers who qualify for the discount program pay a base rate of \$25.00 rather than the full base rate of \$59.75. Consumption charges and the Summer Surcharge are at the regular rate.

## Do you qualify? Here are the requirements that all need to be met:

- You or your spouse are 55-years of age or older, OR permanently disabled.
- You are living in the residence and pay the water bill.
- For 2020, your gross income from all sources is under \$25,000 if single and \$35,000 for a family.
- FOR 2021, INCOME LEVELS HAVE BEEN INCREASED TO \$35,000 FOR SINGLE AND \$45,000 FOR A FAMILY.
